ANNUAL CONGREGATIONAL MINUTES - SUNDAY, JUNE 5, 2016

The annual congregational meeting was called to order by Monica Hepp, council President – on 6/5/2016 at 9:25 am in the Gathering space of Trinity Lutheran Church.

Devotions were led by Pastor Mark Dressel.

The minutes of the 2015 Annual Meeting were reviewed by those in attendance. Hearing no corrections, a motion to approve the minutes made by Kathy Bahner, second by Lani Urbas. Passed.

Monica Hepp advised the attendees to review the committee reports on their own and if there were questions or comments, advise the council.

ELECTIONS:

Church council had three 3 year term positions open. The current nominees brought forward to the congregation included Mike Branzolewski, Adam Smith, & Teri Strohschein. A motion to accept the nominations was made by Brad Rosecke, second from Shawn Cannon. Motion passed.

The Audit Committee had one 3 year term position open & one 2 year term. The current nominee brought forward to the congregation for the 3 year term is Mae J. Laatsch/ Deanna Cannon nominated herself to fill the 2 year term position. A motion to accept the nominations was made by Mike Branzolewski, second by Dan Zastrow. Motion passed.

Synod Assembly Representatives for 2017 - 2 spots open. Holly Ingersoll and Steven Busch were nominated to attend. A motion to approve the nominations was made by Karen Peters, second by Dan Zastrow. Motion passed.

TREASURER REPORT:

The 2015-2016 offering brought in over \$257,000 - which is up almost \$7,000.

Expenses have stayed the same as the previous year for the most part.

Compared to the budget, our expenses were \$14,000 under budget, which exemplifies the principle that if Trinity doesn't need to spend the money, we don't.

Offering exceeded expenses by \$3,000 dollars. The big difference being the increased giving - we appreciated the support. Historical perspective - this is the first year we've put money back into our surplus.

Questions:

Where did we save? Things like having a warm winter and no sub-pastor with Kara around made the difference, they all add up.

PRESENTATION OF THE 2016-2017 BUDGET:

Overall, Trinity isn't projecting a huge increase - just a 2% increase. Budgeted expenses amount to about \$270,000 - below what budg-

eted income is.

One big change for the year is an increase for updated software. It also includes a 2% raise in salaries and increase for office staff benefits to reflect a full year of benefits. No Questions.

Motion to accept the 2016-2017 budget presented by Council as is by Jan Hepp, second by Bob Dimperio. Motion passed.

NEW BUSINESS:

Project Renew Report: Presented by Dan Zastrow

History of the project: a gift was given to remodel the kitchen and that set off a chain of events to start Project Renew. Pastor Mark and Dan looked at the building and created a committee. They decided there was the need for a facelift for the building. Dan and the committee started a wish list with everything Trinity wanted to do. Jenny Koester stepped up to be a part of the project and was able to get a quote from Keller which came to a ballpark number of \$600,000-700,000 to complete everything on the wish list.

The committee then set the priorities of the HVAC system, kitchen, paint, floors, lighting, removal of wall by offices, ceilings and new furniture - with a budget of \$275,000.

By the time pastor returns, the committee would like to have a specific scope of what exactly they'd like to do and who's going to do it.

Please give any ideas/questions to Dan or Cate.

Shawn Cannon - Long-Range Planning:
There's a big difference in our wish list and what Trinity can actually look to accomplish at this point, so looking into a 10 year plan exploring the bigger items that can be waited on in the short term.

Pastor closed in prayer.

Dear Friends,

The Bible says that “those who wait for the Lord shall renew their strength.” Renewal has been a theme this past year as God has opened the door to both renew pastoral energy and revitalize Trinity's building.

After nineteen years of service, nine of them here at Trinity, I was blessed with a summer of rest and renewal in the form of a three-month sabbatical leave. It included a weeklong seminar hosted by Biblical Archaeology Society and much time connecting with family and friends. I am grateful to the sabbatical committee (comprised of Lani Urbas, Monica Hepp, Shawn Cannon, Jamie Stock, Carol Moehrke, and Karen Peters), to the church council, to our Office Administrator Cate Urbas, and to the congregation for their support and hard work to make this possible. I am also grateful to Rev. Gerald Peterson, who provided pastoral support.

When I returned, we scrambled a bit to finish preparing for fall programming. Sunday School undertook its second year with a rotational format. The appeal of this structure is the number of parents and adults who can take part. We held a teacher meeting in the spring to lift up areas of strength and growth so that this feedback can be incorporated into next year's plan. In the absence of Pastor Kara Smith-Laubenstein, who moved to Illinois, I coordinated Youth on Wednesday which trained 16 young people for confirmation in the spring. Senior High on Wednesday continued under the leadership of Chad Patrick and Jeff Constable.

We experienced a bit of a lull in worship attendance through the fall and winter. This could be attributable to a number of factors, including several faithful families moving to other areas of the country, more families having kids in middle school and high school (who may be busier on weekends), aftereffect of pastoral sabbatical, concern about ability to participate in or contribute to Project Renew, or something else. On the positive side, Trinity's music ministries remain strong, with musical offerings including adult and children's choirs, adult hand bell choir, youth chimes, worship band, brass quartet, bluegrass ensemble and more. Also, we began streaming and archiving our 8:15 worship service live on YouTube. Our regular services are receiving between five and fifty views depending on what is happening in the service. Christmas, Easter, and special

events have more hits.

In addition to regular programming, God has provided opportunity and enthusiasm to renew our facility. It has been forty-seven years since Trinity's building was constructed and fifteen years since the new sanctuary was added. In that time, Trinity's building has seen wonderful and continuous use which has helped connect many, many people with God but has also produced some signs of wear and tear. What began as a small undertaking to update a few items in the kitchen has grown into a facility-wide project called Project Renew.

Following a year of dreaming and planning by the Project Renew Committee, facilitated by Dan Zastrow, the congregation contracted with the Enrichment Group and Rev. Luke Bouman to help raise the funding this past January. What is unique about the Enrichment Group is that their campaigns are not entirely about fundraising. As Rev. Bouman stated it, "We do community building, faith building and mission building. If you do those things, the money tends to be there." So, following the Enrichment Group model, Trinity formed the Project Renew Capital Committee, chaired by Eric Bahner. The Capital Committee and the many people they recruited to work on their teams hosted Bible Studies, Enrichment Groups, Children and Youth Events, a Prayer Vigil, an Advanced Commitment Gathering,

and an All Church Banquet. They published and mailed newsletters and invitations, arranged facilities and meals and made a myriad of phone calls to invite people to take part. It was a ton of work and it paid off in fellowship, spiritual practice and a renewed focus on faith and ministry. As I write, the congregation has completed Commitment Sunday and is in the process of making reminder phone calls to kindly ask people to return pledge cards if they are available to do so in preparation for Celebration Sunday.

I am so grateful to God for the renewal that is underway here at Trinity. I am also grateful to all of God's children who take part in the ministry in this congregation. It is an exciting time to be part of Christ's church! May God bless you all.

For just as each of us has one body with many members, and these members do not all have the same function, so in Christ we, though many, form one body, and each member belongs to all the others.



TREASURER - JAMIE STOCK

The 2016 – 2017 annual budget passed during the June 2016 annual meeting with a projected income of \$262,910 and budgeted expenses of \$270,096. Although this was a projected deficit of over \$7,000, the council and congregation was hopeful that we would continue to come in under budget on expenses while seeing spiritual and financial growth.

The financial results for the 2016 – 2017 fiscal year included \$275,179 of income compared to \$265,912 in expenses. This left us with a small surplus of \$9,267. Expenses were up almost 5% over the prior year due to a few known larger purchases. However, income was up over 7% which more than covered the increased expenses. We commend and thank the staff for their continued efforts to control the level of spending and thank the congregation for their continued generosity.

The month by month income and expenses can be found in Exhibit A (page 8) and the month by month expense compared to budgeted expenses can be found in Exhibit B (page 8).

Financial highlights from the 2016 – 2017 fiscal year include:

- Funded church operations and staff salaries including benefits ~\$4,000 below budget
- Replaced one furnace
- Purchased and implemented a new financial management

system

- Purchased and implemented a new membership management system
- Passed on \$20,965 to the greater church from our operating budget and individual contributions
- Paid out one Trinity Note in the amount of \$800, retired a total of \$1,000 in Trinity Note debt
- Paid \$460 in block income to the mortgage principle
- Added \$500 to the funds we are saving for a sabbatical for Pastor Mark
- Added \$1200 to the funds we are saving for the future purchase of a new copier
- Ended the year with an estimate surplus just over \$60,000
- Increased the net worth by more than \$43,000





Dear Trinity Lutheran Church Council:

On May 28, 2017 the Audit Committee consisting of Kathy Bahner, Deanna Cannon, and Mae J. Laatsch audited the financial records of Trinity Lutheran Church for the time period of May 1, 2016 through April 30, 2017. The audit committee would like to congratulate you on the completion of the recommendations of the 2015-2016 Audit Committee.

We, as the Audit Committee wish to make some recommendation based upon the audit results.

Recommendations:

1. The monthly statement should include notes as the transfer, closing, and establishment of new accounts. It was difficult to find where the funds went in the closing and establishment of new accounts.
2. It would also be helpful for the audit committee if there was a description of each income accounts, with a listing of EFT and CC incomes.
3. Found one receipt from Sentry that appears to not have been paid—would suggest that a follow-up on that be done.

The Audit Committee found the financial records of the church to be very well organized and in good order.



2016 ANNUAL REPORT TO MEMBERS**

**To the Voting Members of Trinity Ev. Lutheran Church of Lake Mills
and residents of Trinity Pines Retirement Center**

Trinity Pines Retirement Center was established as a non-profit corporation as a ministry of Trinity Lutheran Church, providing older persons and persons with disabilities housing and services specially designed to meet their physical, social, psychological, and spiritual needs and to promote their health, security, happiness, and usefulness in longer living. The facility is open to all, regardless of church affiliation.

The inspiration for (“The Pines”) arose in the mid 1980s when the members of Trinity Lutheran Church sought a way to extend their mission to the community through the use of a vacant section of land adjacent to the church. Church members saw the need for a retirement facility to allow Lake Mills area residents to retire in the community where they had been living and remain close to their friends and family.

The Pines features a combination of 39 apartments with 1 and 2 bedroom floor plans, community dining room and kitchen, salon, library, activity and craft space, laundry facilities on each floor, pool table, exercise room, and underground heated parking. A ten member volunteer Board of Directors, with representatives from the Church, residents, and the community, provides general oversight with operations under the direction of the Managing Director, Ann Lee. The


Board and Ann are committed to our mission and to balance the independent living needs of our residents with the need for a loving, caring community.

This is a great time to acknowledge and thank all of the residents who volunteer their time and energy to help. From the various committees to the individuals who do things like show the weekly movie, deliver newspapers, and help neighbors with rides, the participation and willingness to help is greatly appreciated.

Occupancy of The Pines remained high in 2016 with a rate of 100% at year-end. The current waiting list includes 8 prospective residents and 3 current residents. Currently, there are no immediate openings so if you or anyone you know is interested, now is the time to get on our waiting list. The most common phrase new residents say is “I wish I would have moved here 10 years ago.”

I am happy to report that the organization is solid financially. For 2016, our net income was over budget thanks to the stable occupancy rate.

Again in 2016, significant improvements were made to our facility. Upgrades to the elevator replaced a number of components and controls, which should allow for seamless future operation. The old roof was removed and completely replaced and will be under warranty for 20 years. The concrete floor in the parking garage was sealed enhancing long-term maintenance and cleaning. Our sincere thanks to our residents for the patience and good humor shown during these projects.

The Managing Director and staff continue to offer social, educational, and nutritional programs for the benefit of our residents. A wide range of social events, entertainment, and educational programs were offered again this year. In 2016 there was a high utilization of these many activities available to our residents and at times to community members. These included both organized activities and just plain spur-of-the-moment fun! Through these different programs, social opportunities for our residents are improved and the community's awareness of The Pines is enhanced.

Our Facebook page continues to be updated with weekly posts and the Tracking Trinity Pines column which was taken over this year by cook Sharon Kassube. We thank resident Marilyn Lohman for her many years of writing this column for the Lake Mills Leader. If you don't already, please "Like" us on Facebook to follow along with the fun happenings which give a glimpse into the life of residents. Also, please write a review of us on our Facebook page.

I encourage members of the congregation to become acquainted with this remarkable community asset that has been serving the community since 1988. We now have a couple generations of the same family who have lived here. Tours of the building will be available following the annual meeting or by contacting Ann Lee.
