





### Annual Congregational Minutes Sunday, June 2, 2013

The annual meeting of Trinity Lutheran Church was held in the Gathering space at 9:30 a.m. on June 2, 2013. The acting president, Dan Havens, asked for a motion to call the meeting to order. Steve Nass made a motion, seconded by Holly Ingersoll, to officially call the meeting to order. Pastor Mark Dressel opened the meeting with prayer. The minutes of the 2012 meeting were reviewed by those in attendance. Hearing no corrections, Dan Havens called for a motion. A motion to approve the minutes as presented was made by Steve Nass, seconded by Mae Laatsch and approved. The congregation was asked to read the committee reports for in the Annual Report found online and printed copy. There were no voiced comments or corrections.

#### **ELECTIONS:**

Church Council: Four positions are open - (three - three-year terms and one - one year term). The slate of nominees was presented: Kyler Kabat - 3 year, Monica Hepp - 3 year, Craig Corsten - 3 year and Ingrid Byrum - 1 year.

Audit Committee: One three year term position is open. Currently, Drew Schoeneck, Kathy Bahner and Deb Haines are serving on this committee. Kathy has completed her term. Mae Laatsch volunteered to fill the open position.

**Synod Assembly**: Next year's Synod Assembly dates are May 3-4 in Wisconsin Dells. The congregation thanked Steven Busch and Holly Ingersoll for serving as our representatives this year. Dan and Sara Havens volunteered to serve in this position next year.

A motion was made by Marie Stark, seconded by Susan White, to accept all nominees and volunteers for the church council, the audit committee and the Synod Assembly positions. Motion passed.

#### TREASURER'S REPORT:

Jamie Stock, treasurer, reported that our income for this church year was \$261,168.88. This is \$722.11 less than 2011. The total expense this year was \$243,668.53 compared to \$240, 245.10. The actual expenses vs. the budgeted expenses showed a positive \$21, 200.82 – under budget. The current year's monthly offering vs. expenses indicates a surplus of \$17, 501.35. Jamie credited the continuing generosity of our members and the consistent volunteerism for the surplus. In addition, Trinity continues to be diligent concerning careful spending practices.

The **proposed budget** was presented to the congregation.

The **proposed income** for 2013-2014 is **\$264,918.52** and the **proposed expenses** are **\$264,062.03**, an anticipated **surplus** of **\$856.49**. Jamie gave an overview/explanation of recommended changes from 2012 to 2013, including:

- Small changes in expense items to reflect actual spending or projected spending increases/decreases
- Reduction in utility budgets due to prices/usage not increasing as much
- Continued funding for new flooring for parsonage not complete last year
- Decrease in copier budget due to proposed savings from purchasing vs. leasing a machine
- 5% salary increase in Pastoral salary and benefits exceeds synod guidelines
- Increase in pulpit supply pastor spending to allow Pastor Mark to take time away in lieu of sabbatical time
- 4% salary increase for staff
- Adjustment in retirement benefit for the office manager due to staffing changes
- A change in funding for janitorial service from once per month to weekly

Jamie further explained the savings of buying vs. leasing a copy machine. This could result in a \$100 savings per month over time.

Acting president, Dan Havens, called for a motion to approve the 2013-2014 budget as presented. Mae Laatsch made a motion, seconded by Julia Wolfgram, to approve the budget. The motion passed. The congregation thanked Jamie Stock, Kim O'Leary and the budget committee for their diligence and expertise.

### **UNFINISHED BUSINESS:**

Pastor was asked about the progress concerning new flooring/carpet for the parsonage. Pastor will continue to research the best materials for the area and report to the council.

George Hamilton made a motion to adjourn the meeting, seconded by Donna Keiner. Motion passed. Dan Havens was thanked for filling in as acting president. Pastor Mark concluded with prayer.

In 2013-2014, with your support, Trinity continued many ministries that have helped people connect with God and show God's love to the world.

- We gathered for worship twice on Sunday morning throughout the year. We also gathered for worship on Wednesday evening through the school year.
- With the help of our faithful teachers, we offered Sunday School to inspire our children's relationship with God through both classroom instruction and service projects.
- Youth on Wednesday continued to facilitate the faith of our middle school students with weekly sessions, a lock-in, a food scavenger hunt (benefitting the food pantry) and more.
- We again hosted Vacation Bible School, Friendship Fair, the Alpha Course, the Holiday Soup and Sandwich Luncheon, Sunday School the Sunday School Christmas Program, the Living Last Supper, Wine, Women and Word, Ladies Lunch Out, Trinity's Trees that Give, outings to St. Mark's Friday Meal and many other events.
- We benefitted from the musical gifts of our Adult Choir, Cherub Choir, Worship Band, Trinity Ringers, Children's Chimes and Brass Choir
- Our faithful Home Communion teams shared the Lord's Supper with members who were

- unable to come to worship.
- We were honored to be able to do many baptisms and weddings.
- We shared the love of God and our hope of eternal life through funerals. A big thank you goes out to everyone who helped with consolation ministry in luncheons that followed.

2013-2014 also brought some new accomplishments and challenges.

- On the joyful side, in 2013, our average weekly worship attendance was over 200 people. This was the second time ever and the first time since 2003. It was a wonderful milestone because Jesus commanded us to make disciples of all nations and in order to do that we need to reach more people. The 2014 year has not had as good a start. The onset of a polar vortex over the winter, complete with frigid temperatures, almost daily snowfalls, and several dangerously icy Sundays has taken a toll on attendance and giving. We are hoping for an improvement as the year goes on.
- During the 2013-2014 school year, we hosted three new events designed specifically to help build and refresh faith. All of them were targeted for adults and accessible to families. "Walking through the Bible 2 (Joshua through Nehemiah)" helped about 50 participants experience a large portion of Old Testament history. "Practical Prayer" involved 30 people in praying for our community and world. "Serious Lenten Trivia" provided an engaging and interactive way to encounter our faith history during Wednesday evening Lenten services.
- We took some steps to improve our facilities and equipment. With your help, through a special funding appeal, Trinity resealed the parking lot and replaced the heat-exchanger of the sanctuary furnace, thus extending the life of both these assets. We were also able to replace our old copy machine, which we had leased at a cost of almost \$6,000 a year, with a new one that we purchased outright (thanks to

your generosity over the past several years). Over the next five years, the savings should be almost \$2,000 per year.

- New for this year, we were blessed with Youth Choir and Youth Chimes to augment our existing musical offerings!
- In an effort to facilitate the next generation of ministry, Council passed a resolution to establish a Mission Endowment Fund. This will provide a vehicle for people who wish to give major or end-of-life gifts so that those contributions can provide an enduring source of funding for God's work through Trinity for many years to come.

It has been a wonderful pleasure to serve alongside you here at Trinity. As you and I carry out the meaningful and sometimes mundane tasks of ministry (it's amazing how much of the work of the Lord is accomplished through seemingly ordinary efforts) we encourage God's children to live in harmony with God. In this endeavor, with the support of the Holy Spirit, we are bringing joy to God and people that will last forever. I look forward to the coming year of ministry together!



### Council and Committee Reports 2013-2014

#### **PRESIDENT**

Growing in Faith...Sharing Christ's Love...

I have to admit that sometimes I say "yes" without thinking about the consequences of my response. We've all been there. Our child asks if we can help with a school function and we say "yes", a few weeks later we hear that "tomorrow morning" we need to supply the classroom with 6 dozen cupcakes. Our spouse asks if we could "help" with a project they are working on and suddenly several hours of our weekend time is taken up and the project we needed to accomplish has once again been put off because we've helped another. Those "consequences" always seem to include my losing out on time and energy to do something I wanted or needed to do. It makes me crabby. I make vows to "never volunteer to do anything again"! I make those vows and sometime later I find myself agreeing to once more do something that's taking up my "precious" time.

This happened to me this winter. I was asked if I serve on the Alter Guild and I said "Sure, no problem, I'd be happy to do that". Yep, did it again. I had no idea that I agreed to partake in a project that would bring me to Church more than once a week to accomplish my promise. I got really crabby about this really fast. I muttered to myself "I'm too busy to do this!" "What was I thinking? I'm such an idiot for agreeing to this!" "I am NEVER going to agree to do ANY-THING for Church again!" Then I felt guilty about my thoughts. There is something intrinsically wrong about preparing the gift of the Blood and the Flesh of Christ for others with the dark cloud hovering about my head. I knew I had to do something. I took myself by the seat of my pants and sat myself down in the Sanctuary and I prayed for a change of attitude. I believed I needed to quickly be able to accept the fact that I had agreed and committed to this service and that I needed to do it with grace and humility.

I love the power of prayer. I could feel a change of attitude overcome me. I found myself in a better place to serve God and our Church community. I seriously considered what I was "giving up" to do this little bit of work which took only minutes from my day. I gave up watching a bit of TV in the evening or having a second cup of coffee on Saturday morning before I showered and ran out of the house. Truthfully, getting going earlier on Saturday meant I was ready to do more of the things I had prioritized for my day. I hadn't lost out at all.

Our Church community has lots needs for your help, energy, commitment and the joy that you can offer in service. It is

one way to live out our words of "Sharing Christ's Love". There are opportunities that will take up only minutes or hours of a day or week and then are done. Some are longer term service opportunities. We need your help to keep Trinity a vibrant and growing community! We look forward to seeing you serving your Church family in the coming year.


### **TREASURER**

Trinity began this fiscal year celebrating another small increase in giving in a time with many changes in the administrator position for the church. Trinity was able to add another \$17,000 to our surplus at the end of the 2012 - 2013 fiscal year, due to the continued effort of the staff and council to control costs. With our surplus sitting at just over \$65,000 the council began to look at strategic plans to spend money more efficiently in the future. We were also hoping for another year of increased programming, increasing membership which would hopefully result in another increase in income

The 2013 – 2014 annual budget passed during the June 2013 annual meeting had an estimated income of \$264,919 and budgeted expenses of \$264,062. At the annual meeting the congregation also approved the church's ability to purchase a copier out of our surplus funds which would allow the church to save over \$10,000 over the typical five year period to rent a copier. In addition, we suggested a plan to put some of the money saved towards saving for the next copier purchase. We also continued to budget for some needed repairs to the parsonage that we had been talking about making for a couple of years but had been waiting to do.

We started out our fiscal year in May and as usual giving was sluggish over the summer but better than most years. During the summer months we were able to move forward with the replacement of the flooring on the first floor of the parsonage. Pastor was able to cut cost by providing labor to replace the solid surfaces on his own and we thank him for his time and talents!

As we headed into the fall, we discovered that we needed a costly repair to our sanctuary heating unit and also realized that we should do routine maintenance to our parking lot including seal coating and crack filling. The council decided to make a special appeal for these projects and with the gen-

erous giving of the congregation we were able to pay both of these projects out of the money raised. We also purchased a new copier in September when our old lease expired.

As we approached the Christmas season giving continued to ramp up as our expenses remained flat. We had a particular blessed Christmas season and looked forward to spring. Following Christmas, as the particularly brutal winter continued on, giving began lag compared to other years. Also, our annual talent show and silent auction fund raising event did not get a lot of traction and it was decided to bypass it this year and look at it again next year.

Easter season approached later than normal this year but spring really had not sprung. Giving followed a very similar cycle this year with only a slight increase as we finished out the year.

At the end of our fiscal year, we were blessed with a total of \$258,063 of income and \$266,818 in expenses. Although there is an initial disappointment that we did not exceed our income from the prior year, we also realize that we raised an additional \$10,000 to cover the special appeal which does place the total giving above the prior year. Our expenses did exceed our income by \$8,755 however we did purchase a copier with a value of \$11,684. Without the purchase of the copier, we would have added almost \$3,000 to our surplus this year. In addition, we were able to complete a long awaited parsonage project and support that within the income received. Our continued strong financial position gives the congregation the ability to continue to think long term and make smart investments in the church. We thank everyone for their generosity, volunteerism and continued commitment to the ministries of Trinity!

As we continue into our new fiscal year, we are grateful that we continue to grow and be financially stable in a time when many other churches are struggling. We pray that we continue to grow as a congregation both physically and spiritually and continued to be blessed with great volunteers and staff. As you evaluate your giving in the upcoming year, consider your blessings and all the great things that are going on here at Trinity and beyond our walls.






### **MAINTENANCE**

### Trinity Pines Retirement Center, Inc. 2013 ANNUAL REPORT TO MEMBERS

## To the Voting Members of Trinity Ev. Lutheran Church of Lake Mills And residents of Trinity Pines Retirement Center

2013 was the 25<sup>th</sup> anniversary of the Trinity Pines Retirement Center. Our residents celebrated the occasion throughout the year by riding on a birthday themed float in the Town and Country Days parade, worked with a local artist to create a collage now on display in the lobby and by enjoying a 25th birthday party playing a Pines-themed game of Jeopardy. In addition there was a nice feature article in the Lake Mills Leader featuring the history of the facility.

The inspiration for Trinity Pines Retirement Center (The Pines) arose in the mid 1980s when the members of Trinity Lutheran Church sought a way to extend their mission to the community through the use of a vacant section of land adjacent to the church. Church members saw the need for a retirement facility to allow Lake Mills area residents to retire in the community where they had been living and remain close to their friends and family.

The Pines was established as a non-profit corporation. It's purpose is a ministry of Trinity Lutheran Church, to which it is affiliated, to provide older persons and persons with disabilities housing and services specially designed to meet their physical, social, psychological, and spiritual needs and to promote their health, security, happiness, and usefulness in longer living. The facility is open to all, regardless of church affiliation.

The facility includes 39 apartments, dining room and kitchen, library, activity and craft space, laundry, billiards room, and underground heated parking. A ten member Board of Directors, with representatives from Trinity Lutheran Church, residents and the community, provides general oversight with operations under the direction of the Manager, Ann Lee. The Board and Ann

are committed to our mission and to balance the independent living needs of our residents with the need for a loving, caring community.

Occupancy of the Pines improved significantly in 2013 with a rate of over 97% at year- end. The current waiting list includes 14 prospective residents. For 2013, income exceeded expenses reflecting the improved occupancy rate. The Board is pleased to have achieved this financial balance necessary to continue to serve our residents.

The Manager and staff continue to develop and put in place nutritional, social, and educational programs for the benefit our residents. Again in 2013 there was a high utilization of the meal program and the many activities available to both our residents and other members of the community. Through these programs social opportunities for our residents are improved and the community's awareness of The Pines is enhanced.

To better prepare and position The Pines for the future, the Board began a strategic planning process in 2013, establishing goals to enhance and capitalize on the strengths of the organization and facility. Moving forward, the Board is very excited as we consider ways to improve and update the facility, ensure available services meet resident needs and renew and refresh our marketing efforts. We look forward to 2014 and beyond with optimism and enthusiasm to maintain The Pines as the residence of choice for area senior citizens.

I encourage members of the congregation to become acquainted with this remarkable community asset that is an outreach of your ministry. Tours of the building will be available following the annual meeting or by contacting Ann Lee.


