Annual Congregational Minutes - Sunday, June 1, 2014

The annual meeting was called to order by Lani Urbas, council president, on June 1, 2014 in the Gathering Space at 9:15 a.m. Pastor Mark Dressel opened the meeting with prayer. The minutes of the 2013 annual meeting were reviewed by those in attendance. Hearing no corrections, Steve Nass made a motion to accept the minutes as presented, followed by a second by Gary Martinson. Motion passed. Lani Urbas advised the attendees to review the committee reports on their own and if questions or comments, advise the council.

TREASURER'S REPORT: Jamie Stock

Jamie reported that our income for this church year was \$258,067.94 – slightly down from last year, but this total does not include dedicated project monies (parking lot sealing and heater repair). Expenses for this church year totaled \$266,817.54, which includes the expense of the copy machine purchase (\$264,062.03 without that purchase). The expense total reflects/includes the following, in additional to normal expenditures: 1) copy machine, 2) flooring for the parsonage, 3) repair parking lot and sanctuary heater (special offering), 4) work-room computer purchase. In summary, the report shows a \$2,929.50 deficit, which includes the purchase of the copier. Without that purchase we would have shown an approximate positive of \$3000. The purchase of the copy machine will result in an approximate savings of \$8000 over a five year period. At this time, Trinity has a surplus of approximately \$58,000. The congregation thanked Jamie and Kim for their continued gift of expertise and time and thanked the congregation for its continued support of the operation and ministry of Trinity Lutheran Church.

ELECTIONS:

Church Council: The slate of nominees for the four open council positions (3-3) year terms and 1-1 year term) were: Tony Newton, Dan Zastrow and Carol Moehrke (3) year); Tracy Neupert (1) year). There were no nominations from the floor. Steve Nass made a motion to accept the nominations, seconded by Mae Laatsch. Motion passed.

Audit Committee: One position open – Kathy Bahner was nominated to fill that position. A motion to accept was made by Erik Bahner, seconded by Monica Hepp. Motion passed.

Synod Assembly: May 30/31, 2015 – Dan and Sara Havens were nominated, followed by a motion to accept that nomination by Steve Nass, seconded by Julia Wolfgram. Motion passed.

Budget Presentation:

The 2014/2015 budget presented by the council:

Projected Income: \$263,010.00 – a 1.9% increase.

Projected Expenses: \$263,363.15

These numbers reflect the following:

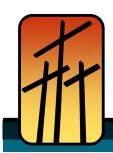
- 1. Reduced parsonage repair (last year flooring)
- 2. Increase benevolence giving by \$1000 (total 19,000)
- 3. Remove three lines from budget Sunday School Service projects, Nursery, Family Promise
- 4. 4% increase for Pastor exceeds synod guidelines
- 5. 4% salary increase for staff
- 6. Increase retirement benefit for office manger

Summary: The 2014/15 budget reflects a \$353.15 deficit.

Steven Busch made a motion to accept the budget as presented, followed by a second – Dan Zastrow. Motion passed.

Pastor Mark closed the meeting with prayer. Julia Wolfgram made a motion to adjourn, seconded by Wayne Moehrke. Motion passed.

PASTORAL REPORTS FOR THE 2014-2015 YEAR

Dear Friends:

As a Christian congregation, Trinity exists to help people make a positive, life-changing connection with God.

We strive to do this by growing in faith and sharing Christ's love.

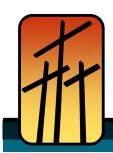
A little over a year ago, our council members had a discussion about what our next step might be as a congregation. Looking at our own lives, we all knew people who did not come to church, and thus do not have the faith support that a congregation can offer. As Jesus tells us to make disciples of all nations, how could we expand our shared ministry to spiritually support more people? Our average yearly worship attendance has been virtually the same for the past 10 years, hovering between 190 and 200 people. Assuming we actually need to have contact with people to support them in their relationship with God, what is keeping us from expanding so that more of God's children have the faith support of a congregation? We talked about the possibility of adding more space. We also considered more staff or a different staffing configuration.

Shortly after this discussion, last June, the property next door came up for sale. Perhaps it was a sign from God that we should build. In order to physically expand the building, in addition to paying off around \$300,000 of existing mortgage, it would very convenient to have land to build on. We pursued a possible purchase even to the point of having a congregational meeting to authorize a bid. As it turned out, the housing market was competitive, and we were outbid by another party. They did turn out to be very nice neighbors. Still, it

was disappointing. After all, the thought of expanding the building had been exciting. But if God was closing a door, perhaps God would open a window.

The window opened in early August with a new staffing opportunity. Our capable Youth on Wednesday (YOW) coordinator, Abby Hale, expressed a desire to teach Sunday School instead. In looking for a replacement, I knew Kara Smith-Laubenstein lived in town and had completed training to serve as a pastor in the Presbyterian tradition. I figured (accurately, it turned out) that she would be more than capable of helping Middle School age kids connect with Jesus. As I considered this, I realized that one of our members had given a \$5,000 gift to start a High School Youth Group. I called her (the donor) to propose a course of action. If we could use the gift to help pay Kara a stipend, and if Kara was willing to coordinate YOW and help with worship two weeks a month, I would try to start a High School Youth Group. Our dear member said yes, Kara said yes, and just like that we had more staff support. Add to this the wonderful, but all-too-brief, presence of Peter Franson who had served for many years as an ELCA pastor and we had quite the team. Sadly, in the fall, Peter was diagnosed with a fast-growing cancer. While we hoped he would recover, the disease claimed his life in January. Nevertheless, the congregation benefitted from Peter's teaching ministry and has enjoyed the services of the now newly-ordained Rev. Kara Smith-Laubenstein for the past year.

This has enabled us to maintain YOW and start Senior High on Wednesday (SHOW), which helps high school students and their families stay tied in with Trinity and with God. In doing this, we have ex-

panded the congregation's ability to help people connect with God throughout their lives. In the coming year, our challenge will be to take advantage of this expanded capacity.

As we go about this, we do face a financial challenge. We have been intentionally saving for the past several years, anticipating the day when we would have either increased expenses or decreased giving. In the coming year it appears that we have both. Giving has been lower in this past year, in part related to the fact that we have lost several elderly members of our congregation who were strong financial supporters of the Trinity. It also happens this year that many of congregation's expenses are increasing. Telephone, database software, and newspaper calendar are all going up. Employee benefits also cost more. Any of these trends would be less than ideal, but together they are truly inconvenient.

On the good side, Trinity is filled with people who are capable, creative, knowledgeable, motivated and looking to use their gifts in God's service. We presently have a pastoral team with expanded ability. We also have an office administrator with over two and a half years of experience with the congregation. Since I have been here, we have never been better prepared to take advantage of the wind of the Holy Spirit blowing through our community.

The work of Christians in a congregation is like sailing. We don't make the wind that brings opportunities and people into our lives - God does that. But we can be better or worse prepared to take advantage of it. With our present level of savings and giving, it looks like we will have 3 years, 1095 days, to take the best ride we can be-

fore finances force us to make substantial changes: to worship with gusto, serve with spirit, pray with passion and interact with God more fully.

Along the way, I hope more of us will grow into being main supporters so that we can enthusiastically carry on ministry for the good of our children. Hopefully, also, the many good things going on here will encourage our friends to take part in the congregation and connect with God through this faith community.

If you are looking for reasons to love Trinity and to recommend it to your friends, remember all the things this congregation has to offer!

Dear Friends,

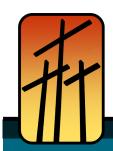

There are many others that easily could be named, but I'm less likely to cross paths with Sunday School teachers (my kids are all grown) or the "counting Ladies" who work every Monday or those who organize the funerals or our Fellowship treats etc..

Our Church, Trinity Lutheran Church, is a community where we find fellowship, comfort, humor, grace and love. It is also a business. Trinity depends on both volunteers and paid staff to run. Both need to be reliable, dependable, know how to get a task done and both need to be smart. We are lucky at Trinity that we have lots of folks who fit those criteria and we've been blessed too.

As a business, we have lots of expenses and about ten years ago we built up our building and our staff on the hopes we would grow with leaps and bounds to bring in the additional income it would take to maintain those expenses. While it seemed we had so much growth, and there was hope of that, it didn't materialize. Ten years ago we borrowed money from the bank each summer to meet the expenses of payroll and bills. Ten years ago we had no savings and we struggled, hoped

and prayed that we'd be able to keep the doors open. Eight years ago we tightened our belts, cut staff, cut every possible expense and made every possible effort to stay within an impossibly tight budget.

Things have gotten better but still are not optimal. We pay all of our bills, on time. We still closely watch our expenses. We have savings. We give back to the larger community. We have two full time staff who deserve to be fully compensated for their very hard and long days. But we need more.

We need you. We need you to volunteer in any way you can. It might be a one time thing or a longer term commitment. We need you. We need you to ask how you can help in case you don't see a place for your talents or your time. We need you. We need you to help grow the church, to bring in your friends and family to become a member of our vital community. We need you to come to make God and Church a real priority in your life so that you can meet the needs of others. We also need your financial support – every week - so that our business can remain strong and you have a Church home that you can be proud of.

Lastly – I want to thank each of you for trusting me to serve you as your Council President for the past six years. It is time for me to step down. It is a time for you to consider stepping into a position on the Council, in the Sunday School room, in the kitchen or garden. Where ever your talents lead you, you are needed and wanted.

TREASURER - JAMIE STOCK

The 2014 – 2015 annual budget passed during the June 2014 annual meeting had an estimated income of \$263,010 and budgeted expenses of \$263,363. The council and congregation was hopeful that we could continue to grow spiritually and also continue to improve our financial position.

The financial results for the 2014 – 2015 fiscal year included \$249,979 of income paired with \$253,502 in expenses. This left us with a deficit during this fiscal year of \$3,523 which was covered by our current surplus from prior years. Although expenses did exceed income, the expenses were \$9,860 below the budgeted expenses for the fiscal year. We commend and thank the staff for their continued efforts to control the level of spending and using our fiscal resources wisely.

The month by month income and expenses can be found in Exhibit A and the month by month expense compared to budgeted expenses can be found in Exhibit B.

Financial highlights from the 2014 – 2015 fiscal year include:

- Funding staff salaries including benefits and operations well below budget
- Addition of Kara Smith-Laubenstein as Associate Minister and the Youth of Wednesday Coordinator due to gifted funds
- Passed on \$21,811 to the greater church from our operating budget and individual contributions
- Paid out one Trinity Note in the amount of \$2,000

- Paid \$2,275 in block income to the mortgage principle
- Added \$500 to the funds we are saving for a sabbatical for Pastor Mark
- Added \$1200 to the funds we are saving for the future purchase of a new copier
- Ended the year with an estimate surplus just under \$50,000
- Increased the net worth by almost \$34,000

We thank everyone for their generosity, volunteerism and continued commitment to the ministries of Trinity! As we continue into our new fiscal year, we are grateful that we continue to have some fiscal stability in a time when many other churches are struggling. However, the upcoming year will bring an increase in our expenses that we will struggle to meet at current giving levels. We pray that we continue to grow as a congregation both physically and spiritually and continued to be blessed with great volunteers and staff. As you evaluate your giving in the upcoming year, consider your blessings and all the great things that are going on here at Trinity and beyond our walls.

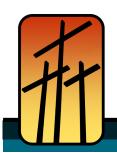

The Men's Bible Study group, which I started in September of 2014, has spawned enlightening and deep discussions by the participating

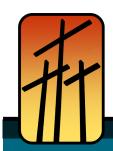

STEWARDSHIP COMMITTEE CHAIR- TRACY MORSE

Greetings Trinity Members:

I was surprised and honored last May to be nominated to be on Trinity's church council for this past fiscal year. I had just found out I was expecting, and moving to Madison to start a life there with my husband, Dan, but how could I say no to this opportunity and calling from my church family? After praying about it, I agreed to a one year term. The term went way too fast, and I wish I had more time to meet goals I had not yet met. I believe we are on the right path for success with the stewardship of Trinity. I was lucky to see our council in action-what an amazing team....all for faith and the sharing of His promise. This congregation is a very lucky group.

When asked which committee on the council I desired, I asked, "What does stewardship mean?" Pastor Mark said "Funny you ask."and he even chuckled. When he explained it to me, I thought that doesn't sound so bad....even if it meant me having to "ask people for money". After all.....this is Trinity Lutheran in Lake Mills. This is my "other family". This is a lot of our member's "other family". This is where friendships are formed. This is where our children get baptized. This is where we pray together for hope and peace. This is where we worship and learn of God's Promise of eternal life.

With this said, my focus this year was the annual stewardship drive, and online, electronic giving. I felt, personally, that electronic giving was an easy and convenient way for our pledges to be fulfilled, as technology is more prevalent in everyone's lives. I, myself, started



giving online, electronically, in 2013 and feel amazing when my quarterly statement comes and I have fulfilled the promise I made to helping Trinity stay on budget.

So, this year Pastor and I put together the stewardship drive letters and spent a couple of Sundays during the drive to help people with questions or concerns about online giving. I believe that people were surprised at how easy it was to give electronically. Since 2012, electronic giving has gone from 32 scheduled payments to 46 scheduled payments, and the amount given electronically went from \$66,927 in 2012 to \$72,138 in 2014. 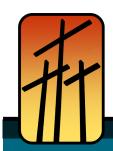

Trinity Pines Retirement Center Inc. 2014 ANNUAL REPORT TO MEMBERS

To the Voting Members of Trinity Ev. Lutheran Church of Lake Mills and residents of Trinity Pines Retirement Center

The inspiration for Trinity Pines Retirement Center (The Pines) arose in the mid 1980s when the members of Trinity Lutheran Church sought a way to extend their mission to the community through the use of a vacant section of land adjacent to the church. Church members saw the need for a retirement facility to allow Lake Mills area residents to retire in the community where they had been living and remain close to their friends and family.

The Pines was established as a non-profit corporation. It's purpose is a ministry of Trinity Lutheran Church, to which it is affiliated, to provide older persons and persons with disabilities housing and services specially designed to meet their physical, social, psychological, and spiritual needs and to promote their health, security, happiness, and usefulness in longer living. The facility is open to all, regardless of church affiliation.

The Pines features a combination of 39 apartments with 1 and 2 bedroom floor plans, community dining room and kitchen, library, activity and craft space, laundry facilities on each floor, billiards room, exercise room, and underground heated parking. A ten member Board of Directors, with representatives from Trinity Lutheran Church, resident representation and the community, provides general oversight with operations under the direction of the Managing Director, Ann Lee.

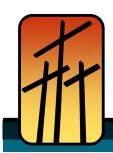
The Board and Ann are committed to our mission and to balance the independent living needs of our residents with the need for a loving, caring community.

Occupancy of the Pines remained high in 2014 with a rate of over 95% at year- end. The current waiting list includes 13 prospective residents. However, there are immediate openings in 2 different one bedroom layouts as those on the waiting list are unable to take advantage of those openings for one reason or another. Please spread the word!

For 2014, income exceeded expenses thanks to the steady occupancy rate. The Board is pleased to have achieved this financial balance necessary to continue to serve our residents.

To better prepare and position The Pines for the future, the Board began a strategic planning process back in 2013, establishing goals to enhance and capitalize on the strengths of the organization and facility. A collaborative planning process that involved The Board's Building Committee including community representatives, resident surveys, and a resident decorating committee provided input to the project's architects, engineers , and designers. The resulting project has incorporated many of those ideas and needs from our residents.

The Individual apartments received upgrades to heating and cooling as well as new and improved lighting throughout. Kitchen cabinets, sinks, and counters are being replaced along with new flooring. New vanities and sinks are being provided in bathrooms. Residents were able to select finishes in kitchen and bathroom.

An addition is being constructed to provide a more intimate home-like dining experience. The existing dining room is being remodeled with improved acoustics and lighting for multi-purpose use. A new lounge with fireplace and counter space is being developed on the first floor. Two new administrative offices is also included. On the second floor, the library will be reconfigured to allow multiple uses including a new large screen television. A new adjacent restroom will be constructed. The existing salon will be upgraded. The common areas will receive new and improved lighting and updated finishes. A new covered and illuminated walkway at the main entrance is under construction as is a new patio with arbor. New trees and related land-scaping will be added with completion the project anticipated in March 2015.

An added benefit to the upgrades and improvements has been the "green" effort that Ann initiated. Rather than ending in a landfill, many of the items being replaced have been recycled and made available for reuse. Through a partnership with the Habitat for Humanity ReStore of Jefferson County, light fixtures, sinks faucets, ceiling fans and appliances have been donated. A local family will benefit from our old gas fireplace and an assisted living facility will give new life to our whirlpool tub.

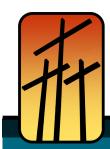
The Managing Director and staff continue to develop and put in place nutritional, social, and educational programs for the benefit our residents. Again in 2014 there was a high utilization of the weekday meal program and the many activities available to both our residents and other members of the community. Recently about 40 youth from Trinity Lutheran Church visited to perform Christmas carols, serve

cookies and cocoa, and most importantly, spend time socializing with the residents This annual event, as well as other activities are examples of the intergenerational fun that occurs at The Pines. It is a win – win. Through these programs social opportunities for our residents are improved and the community's awareness of The Pines is enhanced.

To assist in the community's awareness, this year we enlisted the help of a graphic designer to help create a brand new logo, marketing materials and web presence for The Pines. This refreshed branding and image will tie in nicely with the refreshed building and apartments.
