ANNUAL CONGREGATIONAL MINUTES - SUNDAY, JUNE 7, 2015

The annual congregational meeting was called to order by Monica Hepp, council Vice President – on 6/7/2015 at 9:30 am in the Gathering space of Trinity Lutheran Church. Devotions were led by Pastor Mark Dressel. The minutes of the 2014 Annual Meeting were reviewed by those in attendance. Hearing no corrections, a motion to approve the minutes made by Jackie Erwin, second by Gary Martinson. Passed. Monica Hepp advised the attendees to review the committee reports on their own and if there were questions or comments, advise the council.

ELECTIONS:

Church council had three 3 year term positions open. The current nominees brought forward to the congregation included Jan Hepp & Brad Rosecke. Monica Hepp asked for nominations from the floor. Julia Wolfgram volunteered herself for a position. A motion to accept the nominations was made by Drew Schoeneck, second from Shawn Cannon. Motion passed. The Audit Committee had one 3 year term position open. Deb Haines was nominated to fill that position. A motion to accept the nominations for 2016 - 2 spots open. Brad and Kathy Rosecke were nominated to attend. A motion to approve the nominations was made by Deanna Cannon, second by Sue White. Motion passed.

TREASURER REPORT:

Jamie reported that our income for this church year was \$249,978.91,067.94 – slightly down from last year. Expenses for this church year totaled \$253,502.33. The expense total reflects/includes only normal expenditures, no big purchases were made this year. In summary, the report shows a \$3,523.42 deficit. At this time, Trinity has a surplus of approximately \$50,000. The congregation thanked Jamie and Kim for their continued gift of expertise and time and thanked the congregation for its continued support of the operation and ministry of Trinity Lutheran Church.

The 2015/2016 budget presented by the council:

- Projected Income: \$253,151.00 a 1.9% increase.
- Projected Expenses: \$268,171.89

These numbers reflect the following:

- Reduced parsonage repair (last year flooring)
- Increase benevolence giving by \$1000 (total 19,000)
- Remove three lines from budget Sunday School Service projects, Nursery, Family Promise
- 4% increase for Pastor exceeds synod guidelines
- 1% salary increase for staff

Summary: The 2015/16 budget reflects a \$15,020.89 deficit.

QUESTIONS:

What is the physical plan for the coming years?

- 7 Furnaces that are all the same age. They are functioning and we will try to keep them going, but it is something to keep in the back of people's minds. How big of a deal is it to pass a negative budget?
- Pastor hopes that last year was a big of an fluke. Haven't pushed for cash since the last budget crisis. Hoping that people who are able will step up and help the church. Even if we take a deficit, we have three years to make up this change.
- Mae Laatsch suggests a weekly "What it would take to bring the church up from the deficit?" And per member.

Motion to accept the 2015/2016 budget presented by Council as is by Charley Pinckney, second by Mae Laatsch. Motion passed.

No New Business.

Pastor closed in prayer.

Motion to adjourn made by Drew Schoeneck, Shawn Cannon. Motion approved.

PASTORAL REPORTS FOR THE 2015-2016 YEAR

Dear Friends:

As I sit down to write this annual report, I find myself tempted to simply provide a list of numbers and events. In some ways that's what a report is. It's the official record of what happened in the previous year. In another way, however, I realize that simple lists and numbers do not come close to conveying what God does through Trinity.

As I think back on this past year, I realize the moments that stand out to me are not the attendance figures and financial reports (as important as those may be), but the moments when Trinity people have used their gifts to help one another understand and connect with God.

For instance, this year we had planned to changed the structure of Sunday School in an effort to make it more interactive for the kids and less cumbersome for the adults. To that end, we decided to move from a traditional classroom style of instruction to a rotational style very much like Vacation Bible School. It sounded good, but how would it work?

Effectively, we more than doubled the number of adults involved while dividing up the duties among them so that each has less work. Now, instead of focusing on one Bible account per week in a single classroom, the kids experience a Bible passage four ways over two weeks.

On one of the early weeks, I took a tour of the stations. Outside, I found the "games" area. Darien Dierkes and Jeff Byrum, with Chad and Ashley Patrick and shepherd Julie Hornby, were watching Zach and Luke Byrum kneeling down with plastic cups in their mouths, while blindfolded students stumbled around trying to place

gummy bears in the cups. "What are they doing?" I asked, baffled. Jeff responded, "They're feeding locusts to John the Baptist."

Then I went inside to the craft area where Kirsten Menzies, Jenny Koester and Monica Hepp, with shepherd Shelley Quandt, were focusing on John the Baptist's message. They had a table covered with crayons and paper plates, while on the board were phrases like "Shout the good news," "Jesus is coming," "Jesus is the Messiah," and "Repent!"

I realized that it was working. The teachers were using their creativity and gifts to help our kids experience Bible events and meet Bible characters from different points of view so that the children could understand God's work more fully.

I love moments like that, when people are using their gifts to help themselves and others connect with God. And there were a myriad of them throughout the year.

I remember when our high schoolers were at Twin Oaks Homeless Shelter over the summer. Kyle Gums took the opportunity to teach a young man to throw a football spiral while Kara Sanders was pushing other kids on a swing. They were using their gifts to show love in Jesus' name.

I remember rehearsal for the Living Last Supper. Linda Disch had asked everyone who was moving to freeze and a deadpan voice asked "Is it I?" (echoing the question each character asks as he considers if he is the one who will betray Jesus). It was a funny moment of faith growth when the fact that their Biblical characters were real

live people with feelings and a sense of humor took on life.

I remember talking with Katie Reinfeldt as we scheduled her daughter's baptism for the day of the congregational picnic service at Korth Park. I told her that we'd be happy to do it, but warned her that it would not be in the church building. She responded that her daughter had come into the world in an unconventional way (being born at home before they could start for the hospital) so she might as well enter the church in the same way. It was an amusing acknowledgement that life is unpredictable and the work of the church extends beyond the walls of the church building.

Moments like these, where our relationship with God impacts our daily life, help convey what Trinity "is" as much as the facts and figures that attempt to quantify the events of a year.

That being said, facts, figures, and significant events do make a difference. So here are some from the past year:

- 95 kids and 73 adults kids took part in Everest Vacation Bible School. This year we encountered rain and thunder for the first time.
- 91 children and 28 adults took part in Sunday school, which began with ever popular Friendship Fair and included the Sunday School Christmas Program "Arise, Shine."
- 20 people and one dog took part in the Town and Country Days parade, handing out water and fliers for Vacation Bible School.
- 14 people participated in Second Sunday Prayer throughout

the year.

- Pastor Kara Smith-Laubenstein was a great blessing to the ministry at Trinity through much of the school year until she accepted a full-time call at First Presbyterian Church in Libertyville, Illinois in March, 2016.
- 49 students and 11 adults took part in Youth on Wednesday. In addition to weekly classes, they held a fall lock-in and a spring food scavenger hunt (which collected 1,430 pounds of food for the food pantry).
- 11 students went on the High School Mission Trip and 17 participated in Senior High on Wednesday. They held a new "Super Bowl Sub Sandwich" fundraiser, and went on a ski trip. Chad Patrick and Jeff Constable have agreed to facilitate the group next year.
- Numerous people took part in Worship band, Bluegrass Sunday, Advent Cantata, Adult and Children's Chimes, Adult Choir, Youth Choir, Middle and High School Choir. We were blessed with a great deal of musical leadership in the form of Drew Schoeneck, Linda Disch, Betty Oertel, Kim O'Leary, Megan and Jeff Sauter, Leah Fritsche, Sarah Hafenstein, Linda Branzolewski, Jamie Syvrud, Monica Hepp and others.
- 13 presentation teams took part in the Friday night "Jesus Expo." The presenters felt that we could easily do a similar event next year between Sunday services.
- 16 people tend to take part in Ladies' Lunch Out in any given month.

- 14 children took first communion.
- 8 young adults were confirmed.
- 12 high school seniors were presented with senior blankets.
- 60 people helped raise \$4,000 for the food pantry through the Christmas Tree sale.
- Trinity's Dartball team took second in league and second in tournament.
- Wine, Women and Word and Sarah Circle worked for spiritual growth.
- 9 people received home Holy Communion through the efforts of our home communion teams.
- And much more.



The 2015 – 2016 annual budget passed during the June 2015 annual meeting with a projected income of \$253,151 and budgeted expenses of \$268,172. Although this was a projected deficit of over \$15,000, the council and congregation was hopeful that we would continue to come in under budget on expenses while seeing spiritual and financial growth.

The financial results for the 2015 – 2016 fiscal year included \$257,265 of income compared to \$253,950 in expenses. This left us with a small surplus of \$3,315. The level of expenses was almost the same as the prior year. The main difference was the increase in income this year. We commend and thank the staff for their continued efforts to control the level of spending and using our fiscal resources wisely and also the congregation's increased generosity.

The month by month income and expenses can be found in Exhibit A and the month by month expense compared to budgeted expenses can be found in Exhibit B.

Financial highlights from the 2015 – 2016 fiscal year include:

 Funding staff salaries including benefits and operations ~\$14,000 below budget

- Retained Kara Smith-Laubenstein as Associate Minister and the Youth of Wednesday Coordinator due to gifted funds
- Passed on \$20,884 to the greater church from our operating budget and individual contributions
- Paid out one Trinity Note in the amount of \$1,000
- Paid \$1,635 in block income to the mortgage principle
- Added \$500 to the funds we are saving for a sabbatical for Pastor Mark
- Added \$1200 to the funds we are saving for the future purchase of a new copier
- Ended the year with an estimate surplus just under \$53,000
- Increased the net worth by more than \$43,000

We thank everyone for their generosity, volunteerism and continued commitment to the ministries of Trinity! We pray that we continue to grow as a congregation both physically and spiritually and continued to be blessed with great volunteers and staff. As you evaluate your giving in the upcoming year, consider your blessings and all the great things that are going on here at Trinity and beyond our walls.

Trinity Pines Retirement Center Inc. 2015 ANNUAL REPORT TO MEMBERS

To the Voting Members of Trinity Ev. Lutheran Church of Lake Mills and residents of Trinity Pines Retirement Center

The inspiration for Trinity Pines Retirement Center (The Pines) arose in the mid 1980s when the members of Trinity Lutheran Church sought a way to extend their mission to the community through the use of a vacant section of land adjacent to the church. Church members saw the need for a retirement facility to allow Lake Mills area residents to retire in the community where they had been living and remain close to their friends and family.

The Pines was established as a non-profit corporation as a ministry of Trinity Lutheran Church, providing older persons and persons with disabilities housing and services specially designed to meet their physical, social, psychological, and spiritual needs and to promote their health, security, happiness, and usefulness in longer living. The facility is open to all, regardless of church affiliation.

The Pines features a combination of 39 apartments with 1 and 2 bedroom floor plans, community dining room and kitchen, library, activity and craft space, laundry facilities on each floor, billiards room, exercise room, and underground heated parking. A ten member volunteer Board of Directors, with representatives from the Church, residents, and the community, provides general oversight with operations under the direction of the Managing Director, Ann Lee. The Board and Ann are committed to our mission and to balance the independent living needs of our residents with the need for a loving, caring community.

This is a great time to acknowledge and thank all of the residents who volunteer their time and energy to help keep things up around here. The participation and willingness to help is greatly appreciated.

Occupancy of the Pines remained high in 2015 with a rate of 100% at year-end. The current waiting list includes 5 prospective residents. Currently, there are no immediate openings so if you or anyone you know is interested, now is the time to get on our waiting list. The most common phrase new residents say is "I wish I would have moved here 10 years ago."

I am happy to report that the organization is solid financially. For 2015, our net income was over budget thanks to the steady occupancy rate. In March we entered a new financial arrangement with Bank of Lake Mills and paid off the original mortgage with the Wisconsin Housing and Economic Development Authority (WHEDA). WHEDA was a partner in establishing the Pines, but we now enjoy more favorable terms and an available borrowing cushion from our local bank if needed.

The expansion and common area remodeling project was completed this spring. Improvements to dining, lounge and library have enhanced the warm comfortable atmosphere and the new covered walkway is both practical and welcoming. The upgrades to the individual apartment kitchens, bathrooms and lighting as well as heating and air conditioning have made a significant difference. Due to our

new financial arrangement, we were able to provide funds for this work without raising the rent for current residents.

A brand new feature for this year was the creation of 6 standing planter boxes, designed and built by local scout Shelby Riggleman as his Eagle Scout Project. This will allow residents to enjoy some manageable gardening at their leisure.

Moving forward, we have organized a Planned Replacement Schedule for the appliances and carpeting in the apartments, based on a combination of age of appliance and longevity of residency of the tenant.

In October, at the Lake Mills Area Chamber of Commerce Annual Meeting, Trinity Pines was recognized as "Business of The Year." We are all proud of this honor.

The Managing Director and staff continue to develop and put in place nutritional, social, and educational programs for the benefit our residents. During this year, a food service committee was established with residents and staff. This collaborative effort in menu planning and delivery has resulted in increased satisfaction and utilization of the weekday meal program. It also helps residents understand firsthand the relatively complexity. The recent availability of carry out meals on weekends has been well received.

Again in 2015 there was a high utilization of the many activities available to both our residents and other members of the community. A wide range of social events, entertainment and educational programs were offered this year. These included both organized activities and just plain spur-of-the moment fun! Through these different programs, social opportunities for our residents are improved and the community's awareness of The Pines is enhanced.

Our updated logo, marketing materials and web presence for The Pines reflects our optimism for the future. This refreshed branding and image has tied in nicely with the refreshed building and apartments. If you don't already, please "Like" us on Facebook to follow along weekly with the fun happenings which give a glimpse into the life of residents. Also, if you would take 2 minutes to write a review of us on our Facebook page, that would be appreciated.

I encourage members of the congregation to become acquainted with this remarkable community asset that has been serving the community since1988. Tours of the building will be available following the annual meeting or by contacting Ann Lee. See for yourself the exciting and refreshing changes at The Pines!


